Terms and Conditions

The Great Adventure Giveaway consists of two promotional mechanics:

- 1. Win Instant Prizes In-Store**
- 2. Win a R5,000 Domestic Flights Voucher Lucky Draw**

The promotion is hosted by Destinations Outdoor & Travel at Town Square at Newmarket.

Promotion Period: 20 April – 6 May 2026

1. Win Instant Prizes In-Store

- Customers who make a purchase of less than R1,500 (i.e.: R1499 or less and not equal to R1,500) in a single transaction at Destinations Outdoor & Travel, Town Square at Newmarket, during the promotion period, will receive one (1) Adventure Reveal Card, while stocks last.
- A maximum of one (1) Adventure Reveal Card per qualifying transaction will be issued.
- Only one (1) Adventure Reveal Card per customer per day is permitted. Multiple transactions by the same customer to obtain additional cards will not be allowed.
- A total of 204 Adventure Reveal Cards will be available for the duration of the promotion.
- Adventure Reveal Cards will be distributed at an approximate rate of 12 cards per day, while daily stock lasts.
- Customers must open the Adventure Reveal Card in-store to reveal whether they have won a prize.
- Prizes may include vouchers, outdoor merchandise, or other promotional items, at the promoter's discretion.
- Winning Adventure Reveal Cards must be presented in-store at Destinations Outdoor & Travel, Town Square at Newmarket, to redeem the prize.
- Adventure Reveal Cards that are damaged, tampered with, altered, copied, or illegible will be deemed invalid.
- Prizes are not transferable and may not be exchanged for cash.
- The promoter reserves the right to substitute any prize with one of equal or greater value, if required.

- If the winner cannot be contacted within 7 (seven) days, the promoter reserves the right to select an alternative winner.
